

# **DANCE & CAMPUS CONTEST SAINT FRANCIS OF PAOLA**

**27th April – 1st May 2024**

**Art Direction: George and Maria Postelnicu**

## **REGULATION**

*The Dance Contest & Campus San Francesco di Paola* is an event open to dancers, schools and groups. The event will include training days in different disciplines and a final contest with many prizes for each category.

The training days will be held from 27 to 30 April 2024 in Bucharest (Romania) and they will be divided like this:

- All INTERMEDIATE level participants will take lessons at LA SYLPHIDE ACADEMIC BALLET SCHOOL - STR PARINTELE GALERIU 12 - BUCHAREST ROMANIA
- All ADVANCED level participants will take lessons in two locations different and will be distributed as follows:
  - on April 27th and 28th the lessons will take place at LA SYLPHIDE ACADEMIC BALLET SCHOOL - STR PARINTELE GALERIU 12 - BUCHAREST ROMANIA
  - on April 29th and 30th the lessons will take place at the THEATER NATIONAL OPERETTA – BUCHAREST

Classes will be divided into the following age groups:

- Beginner 1: 6 - 8 years
- Beginner 2: 8 – 11 years
- Children: 11 – 13 years
- Professional Children: 11-13 years
- Junior: 13 - 17 years
- Professional Junior: 13 – 17 years
- Senior: 17 years and up
- Professional Senior: 17 years and up.

And in the following disciplines:

- Ballet
- Modern

- Pas de deux
- Open
- Contemporary
- Character
- Theoretical Course for teachers (update Vaganova ballet method according to the Bucharest Academy of dance teaching program)

## **Costs seminars**

- four days of lessons: € 500,00 (all ages)
- three days of lessons: € 330,00 (all ages)
- two days of lessons: € 220,00 (all ages)
- one day of lessons: € 100,00 (all ages)
- a single lesson: € 35,00 (all ages)
- two lessons on the same day: € 60,00 (all sections of age)
- three lessons on the same day: € 75,00 (all ages)
- theoretical course for teachers: € 25,00

The contest will take place the 1st of May, 2024 in Bucharest (Romania) at the National Opera Theater “Ion Dacian”.

Entrance to the Theater for the Contest phase will cost € 8,00 to person (40,00 Lei) therefore it will be necessary to buy tickets.

The competition will be divided into the following age groups (categories):

- Beginner 1 (6-8 years, completed by July 15, 2024)
- Beginner 2 (8-11 years, completed by July 15, 2024)
- Children (11-13 years, completed by July 15, 2024)
- Professional Children (11-13 years, completed by July 15, 2024)
- Junior (13-17 years, completed by July 15, 2024)
- Professional Junior (13-17 years, completed by July 15, 2024)
- Senior (17 years and over)
- Professional Senior (17 years and over)

And according to the following disciplines:

- Ballet (for soloists, pas de deux, groups)
- Modern (for soloists, pas de deux, groups)
- ballet character (for soloists, pas de deux, groups)
- open (for soloists, pas de deux, groups)

- contemporary dance (for soloists, pas de deux, groups)
- choreographic composition (for soloists, pas de deux, groups).

## **Costs of participation in the contest**

1. For those who are also enrolled in the seminars scheduled April 27 to 30 for all four days of lessons, the entry costs to the competition will be as follows:

- Soloists: € 50,00 (For soloists wishing to participate with more than one variation, the prices will be as follows: € 50,00 for the first variation, € 40,00 for the second variation, € 30,00 for the third.)
- Pas de deux: € 90,00
- Groups: € 120,00 (max. 10 elements. Beyond this threshold, it is necessary to add, to the expected share, € 10,00 for each component in more)
- Choreographic composition: € 150,00 (max. 7 items. Beyond this threshold, it is necessary to add to the expected share, € 10,00 for each component more)

2. For those who are also enrolled in seminars scheduled April 27 to 30 for less than four days of lessons and for those who want only to participate at the final contest, the registration costs will be as follows:

- Soloists: € 80,00 (For soloists wishing to participate with more than one variation, the prices will be as follows: € 50,00 for the first variation, € 40,00 for the second variation, € 30,00 for the third.)
- Pas de deux: € 140,00 .
- Groups: € 150,00 (max. 10 elements. Beyond this threshold, it is necessary to add to the expected share, € 10,00 for each component increase)
- Choreographic composition: € 180,00 (max. 7 items. Beyond this threshold, it is necessary to add to the expected share, € 10,00 for each component more)

It should be noted that only those who participate in the entire seminar for a total of 4 days will be able to take advantage of any scholarships in possession and the relative discounts (for which the participants of the seminar for 1,2 or 3 days of class will not be able to take advantage of the scholarships' reductions).

We also remind you that the subsidized cost of scholarships at 50% is Euro 250 (instead of Euro 500).

The registration for the competition and / or internships will not be refunded in case of non-participation or withdrawal (except for confirmed cases of the disease , upon presentation of medical certificate), and can't be sold, in any way, to another person.

The choreography must have a maximum duration of:

- Soloists: 3 min.

- Pas de deux (classical repertoire): 9 min.
- Pas de deux (all other disciplines): 4min.
- Groups (all styles): 4,30 min.
- Choreographic composition: 7 min

For phase competition, competitors should send audio track by email to e-mail address [roxana.grama@gmail.com](mailto:roxana.grama@gmail.com) by specifying:

- The name of the school entered the contest and / or participants (in case of solo and duet)
- Discipline (style)
- Choreography Title and duration of the same.

## Awards (Competition) **(BEING UPDATED)**

- Soloists awards:
  - Senior Category***  
The 1st Class, for each dance style, will receive a cash prize of € 100,00.  
The 2nd and 3rd place, for each dance style, will receive the awarding of scholarships and the Diploma certificate.
  - Category Junior, Children, Beginners 1 and 2***  
The 1st, 2nd and 3rd place, for each dance style, will receive the awarding of scholarships, Diploma certificates and dance accessories.
- Group Awards:
  - All Categories***  
The 1st, 2nd and 3rd place, for each style of dance, will receive the awarding of scholarships.
- Special award of € 250,00 for the best choreography (Choreographic Composition).
- Special award for the Best Dancer of € 400,00.

The panel will announce the winners of the competition immediately after the performance of all the candidates and the judgment will be final. In addition, the direct interested parties will be able to see, onrequest, the votes related to their performances.

The directors of theaters and ballet companies, in committee, will have the right to assign all the prizes offered or only a part of them.
